## Ronald Riccio appointed new dean of law school

Ronald J. Riccio was appointed dean of Seton Hall's School of Law, effective July 1. Monsignor John J. Petillo, the University chancellor, announced the appointment in May.

Riccio has definite plans for the law school's future. Among those plans is helping to supervise construction of a new law school building in Newark, maintaining and adding to the excellent faculty, establishing endowments and chairs, as well as scholarships for minorities, and increasing the alumni's involvement in the law school. The new dean strongly believes in the positive influence of Catholic education and, indeed, the law school's new chaplain, Monsignor Harold Darcy, now has an office at the school and will celebrate daily



Masses for those students who wish to attend.

Riccio was born and raised in Jersey City, attending Our Lady of Victories School in Jersey City and St. Michael's High School in Union City. Attending college on a baseball scholarship, he earned his B.A. in history with honors from Seton Hall University, and in 1968 received a medal from the Eastern Collegiate Athletic Conference for athletic and academic achievement. His J.D. is from Seton Hall Law School, where he was a member of the Law Review. After law school, Riccio served a judicial clerkship for U.S. District Court Judge Lawrence A. Whipple. He was a partner for more than 15 years in the firm of Robinson, Wayne, Levin, Riccio and LaSala in Newark and is a highly regarded trial and appellate lawyer.

Dean Riccio resides in Little Silver, New Jersey, with his wife Nina and their daughters Nicole and Julie.

## Construction to begin on new law school building

Plans are under way to begin construction of a new Seton Hall Law Center complex covering approximately 200,000 square feet on the site of the current law school in Newark. Bellemead Development Corporation of Roseland will construct the complex. The University has entered into a separate agreement with Bellemead in which ownership of the current four-acre site transfers to Bellemead in return for property almost double the acreage in Roseland. A new office building on the Roseland site will also be owned by the University. Leasing the building will generate income to help offset the \$25 to \$28 million cost of constructing the new law school.

While the University received favorable tax abatements from the city, Newark stands to gain long term returns from payroll and parking taxes as well as projected revenues of \$40 million in lieu of taxes.

Law School Dean Ronald Riccio and University Chancellor Monsignor John Petillo estimate a Spring 1991 opening for the new law school and at least one office tower. As plans stand now, the complex will house the law school and two office towers, as well as an adjoining retail plaza. The city has pledged parking facilities.

The decision to stay in Newark is quite understandable. Newark is an important legal hub with New Jersey's busiest state and federal courts, state appellate courts and the U.S. attorney's office all in residence. The Newark Legal and Communications Center is now under construction in the busy downtown area as well. With state-of-the-art academic and library facilities, the new Seton Hall Law Center promises to be one of the most modern and highly visible law school's in the country.

# Law school chaplain appointed

Monsignor Harold P. Darcy was named chaplain to the law school in June. Monsignor Darcy was ordained on December 8, 1954 in Rome, Italy. He earned his J.C.D. degree, summa cum laude, from Gregorian University in Rome in 1960, his S.T.L. degree in Systemic Theology, magna cum laude, from Gregorian University in Rome in 1955, and his B.A. degree in Classical Languages and Philosophy, magna cum laude, from Seton Hall University in 1951.

He was an honorary prelate in 1971 and chaplain of His Holiness in 1962.

Monsignor Darcy has served as pastor of Notre Dame Parish in North Caldwell since 1979. He also served as rector of the North American College in Rome, Italy, from 1974 to 1979, and of Immaculate Conception Seminary in Darlington, New Jersey, from 1972 to 1974, where

# Rodino appointed visiting professor

Congressman Peter W. Rodino Jr., who is retiring after serving 40 years in the House of Representatives, has been appointed as a Distinguished Visiting Professor to the law school. The congressman has also agreed to donate his papers, including those from the Watergate hearings, to the law school archives. Among his many accomplishments in the House over the years, the congressman served for more than a decade as chairman of the House Judiciary Committee. Rodino's term in Congress expires in January and he is expected to devote time to the University beginning next spring.

## 1800 alumni pledge \$680,000 to Annual Fund

This year, for the first time, the alumni phonathon was conducted by an outside organization: Institutional Development Council. The facilities at the IDC Phone Centre in Montclair made possible continuous calling by a group of trained "communicators" ensuring the maximum effort to reach all law school alumni.

Under the supervision of Phyllis Dunlop, director of development at the law school, calling began on March 18 and was completed on July 1.

The results were as follows:

Over \$680,000 was pledged by 1800 alumni, double the number who had ever donated in any previous fund year. Including po-

tential corporate matching gifts, the total is \$735,000. Two-thirds of the pledges will be paid over the next three years in annual or quarterly installments and the remaining one-third will be received within a year.

Especially impressive was the participation of the Class of 1987. Fifty-five percent of the class made pledges for a total of \$24,000. In addition, 42 percent of all previous non-donors pledged a total of \$285,000, 38 percent of the final total.

As of July 1, 1988, the close of the 1987/1988 Fund year, the money received and credited to the ninth Annual Fund was as follows:

The alumni total was 30 percent over that of 1986/1987 with an increase of 81 donors.

## Fifth Annual Sports Law Symposium is popular and informative

Once again the major function of Seton Hall's Sports Law Forum proved popular and informative. The 5th annual sports law symposium was held in April at the Gateway Hilton in Newark. Panel discussions focused on problems and opportunities in establishing a sports law/ representation practice and the impact of media coverage as sports law emerges. Not surprisingly, collusion among the owners, an often reported issue, was brought to the fore. Tom Seaver, former New York Mets pitcher, spoke of his own negotiating experience before the days of player representation.

Other participants included sportswriters Phil Pepe and Dave Anderson, agent David Fishof, sportscasters Don Criqui and Bill Raftery, as well as sports law attorneys Barry Rona, Kenneth Kunzman, Art Kaminsky, Larry Fleisher and Mel Narol.

Keynote speaker George Steinbrenner (principal owner of the New York Yankees baseball team for those of you reading this in Rangoon) had no problem with speaking for almost an hour about himself, the Yankees in general,

Billy Martin and Dave Winfield in particular, and his guidelines for a foreign policy, in which the U.S. puts an end to foreign aid "until every kid in this country is assured of a quality education." Also in attendance was Peter J. Carlesimo, who led Seton Hall University's basketball team to the NCAA Tournament. Carlesimo

received a much deserved Distinguished Service Award.

Symposium co-directors Lawrence Bershad and Richard J. Regan, as well as the Forum's student committee members, successfully pulled together just the right elements to produce an invigorating meeting — by turns thoughtful and entertaining.

#### **Alum named MAAC commissioner**

Richard J. Ensor '87 was named commissioner of the Metro Atlantic Athletic Conference in August, the third commissioner in the league's eight-year history. For the past two years, Ensor has been an assistant professor in the Sports Management Department at the University of Massachusetts, where his concentration was on sports marketing and sports law. He earned a master's in sport management from the University of Massachusetts, Amherst, in 1983.
