**Description:** International Political Economy (IPE) is a thoroughly interdisciplinary subject which focuses on the interaction between politics and economics on a global scale. This course aims to provide students with a thorough introduction to this field of study. Students will learn about the contending theoretical approaches to the study of IPE, the history of the global economy from the Industrial Revolution until today, and the key issues in global economic relations.

**Course Procedures:** The classes will be a combination of formal lectures, and informal seminars. The informal seminars will involve an open discussion of the issues discussed in the lecture and an engagement with the required reading(s). Active student participation is essential!

**Course Requirements:**

*Research Paper* (3000 words): Students are required to engage with a topic of their choice from the vantage point of a particular theoretical approach to IPE, whether realist, liberal or critical. Students must submit a plan of their essay to me by **October 6<sup>th</sup>**. This plan should contain their core research question, a rough outline of their theoretically informed explanation, and a list of sources that will be engaged with. The completed paper is due in class on **November 10<sup>th</sup>**. Students are expected to use at least 8-10

sources and to not overly rely on the core textbook. Sources must be cited correctly and you must include a bibliography.

*Class Participation:* Students will be graded on their preparation and willingness to actively participate in class discussions, as well as their attendance.

*Final Exam:* This examination will focus on the area of the course titled 'Issues in IPE'. The exact format will be outlined at a later date.

Your final grade will be composed of the following:

***Research Paper: 40***

***Class Participation: 20***

***Final Exam: 40***

**Required Readings:** Students are responsible for the purchase of one book. This book is available for purchase from the campus bookstore, but you may also order it online.
