This course will expose participants to fundamental understanding of religion, law and war focusing on the nexus of the three. It will do so in a highly participatory manner. The course will focus on the three terms separately and in relation to each other. As both CORE and Diplomacy course, students from different background will be encouraged to learn from one another and be aware of their own learning. The course will encourage a critical subjective response from participants. It will invite an analysis of three original documents: the Vatican II document 'Nostra Aetate'; the United Nations Declaration of Human Rights; and the UNESCO document on peace as well as actual cases of interest.

Students are required to come to class with a computer or a tablet or a smartphone. If you do not have a mobile device to bring to class each time please contact the instructor.

### Primary Student Learning Outcomes

By the end of the semester, students should have acquired knowledge and understanding of collective, cultural patterns related to religion, law and war; they should have develop an understanding of their own articulation of concepts and experiences related to religion, law and war. Students should also have developed the skills to analyze complex situations, synthesize information, share knowledge with others and offer/welcome feedback.

#### Emphasis on Language

Students may submit their work through a valid SHU e-mail and expect to a turnaround of two to five working days.

### Grading:

40% of the grade will be on the final paper, on a topic to be determined in consultation with the professor on an issue identified during the first three classes. A draft with outline is due after mid-term and will be presented and discussed in the assigned team.

20% of the grade will be based on class participation, especially logs and teams. Each class a random list will be generated and students will be asked to comment aloud on the reading. The grade will include presentations and discussions of portions of material in class, participation in teams; doing informal class assignments; being a discussant of the readings; giving a short report on an additional issue or current event.

40% will be based on a personal log to written about each unit and shared with the professor and others on the evolving understanding of religion, law, war and the relationships among them.

Teams will be formed randomly and participation in the team will be part of the learning experience. Grades will be assigned individually but will take into account internal feedback of all members of the team on the contribution of each member. Teams will meet in class each week. Because effective teamwork is challenging, Prof. Bartoli will offer detailed guidance on expectations and will be available by email, phone and in person 24/7 during the entire course.
