## Methodology and objectives

#### Objectives

- 1. To develop an understanding of the post-9/11 era with respect to the role of the state and the nature of the "new wars."
- 2. To identify and analyze the actors and theory that address global conflict and its prevention.
- 3. Through the students' individual research and/or interest in a specific region, identify and discuss the issues concerning the basilar societal, economic, political and cultural elements, which beget tension, and trigger violence. As well, present recommendations and prospects for the control of conflict in the case study of choice.

#### Basis for grade

Written research paper on a regional case study
 Take home mid-term exam of no more than 7 – 10 pages
 Constructive and informed class participation\*

\*During the final weeks of the semester, students will have a chance to lead the seminar in a discussion of their research topic. This will be an opportunity to share preliminary findings, as well as receive feedback on the thesis.

**Required readings** will include several standard texts. In addition, some materials will be provided in class. Depending upon the interests of the class and the direction and content of the discourse, alternative reading material may be introduced in order to accompany and enrich discussions.
