FOREWORD

The Center for Public Dispute Resolution (Center) was established in 1984 by the New Jersey Department of the Public Advocate with support from the National Institute for Dispute Resolution and the State of New Jersey. The Center is located within the Department of the Public Advocate, Richard J. Hughes Justice Complex, 25 Market Street, CN 850, Trenton, NJ 08625, (609) 292-1773. Eric R. Max is Director of the Center.

The Center resolves public interest disputes, offers training in dispute resolution techniques, addresses issues relating to the field, and generally serves as a center for the practice of alternative dispute resolution (ADR) in the state. Public interest disputes are those which involve public entities, impact on public policy, or otherwise affect the public interest. Such disputes include, but are not limited to, environmental, planning, land use or regulatory issues. In the past, the Center has served as a master/mediator in cases involving: the Burlington County Board of Freeholders; the City of Camden; the Camden County Municipal Utilities Authority; the New Jersey Department of Transportation; and private corporations. Cases are referred to the Center by the courts, public agencies, disputants or concerned individuals.

The Center helps parties identify and select the dispute resolution process best suited for their dispute and provides the appropriate people and services needed to assist in the resolution of that dispute. Its services include dispute analysis, facilitation, policy dialogues, mediation, fact-finding, and arbitration. In addition to its staff, the Center has access to a pool of qualified mediators and other third-party neutrals who have expertise in many of the subjects involved in public interest disputes.

The Center provides training programs to the judiciary, the Bar, public agencies, community groups and others in negotiation, facilitation, mediation, and other dispute resolution techniques. Specific groups trained include administrative law judges, lawyers, law clerks, state agency personnel, planning officials, probation officers, and court mediators.

In addition to its dispute resolution and training services, the Center is also committed to addressing important issues in the dispute resolution field. Thus, on December 7, 1987, the Center convened a select group of jurists, scholars, and mediators at Princeton University to participate in a Symposium on Critical Issues in Alternative Dispute Resolution (Symposium). James E. McGuire coordinated the Symposium.

The goals of the Symposium were to explore in depth the issues of mediation confidentiality, use of special masters as mediators, mediator standards, and to share the findings with the ADR field. The Center commissioned a discussion paper for each of these issues in order to focus and stimulate the Symposium panel discussions. Each panel was charged with developing a specific work product that would be of practical use to ADR programs facing similar issues. Finally, the Center commissioned three additional papers to provide a summary and analysis of the Symposium discussions for each of the three issues. The issues and participants are identified below.

Panel I—Mediation Confidentiality. This panel reached consensus on a model statute/rule on confidentiality. The panel considered the following issues:

- Should there be a privilege for communications made within the context of a mediation?
- * Who qualifies as a mediator?
- * Should the privilege be absolute?
- * If not, what exceptions should be specified?
- * What happens if there is a conflict of duties?
- * And other issues which emerged from the discussion.

Michael L. Prigoff, Esq., member of the American Bar Association Standing Committee on ADR, prepared the discussion paper. Jonathan M. Hyman, Esq., Associate Professor of Law, Rutgers University Law School, moderated the panel discussion, drafted the model statute/rule, and prepared the summary analysis article. Panel participants included: Ralph Bean, Ph.D.; Daniel P. Dozier, Esq.; Samuel G. Forlenza; Eric D. Green, Esq.; Nancy H. Rogers, Esq.; and Honorable Eugene D. Serpentelli.

PANEL II—USE OF COURT-APPOINTED MEDIATORS AND SPECIAL MASTERS. This panel developed a bench manual offering guidance to judges, parties, and neutrals involved in a court-ordered mediation. The panel discussed the following issues:

- * Ex parte communications between the mediator and the judge.
- * Ex parte communications between the mediator and the parties.
- * What effect and force should be given to a master's or mediator's report?
- * What type of relationship should exist between the master or mediator and judge?
- * Due process rights where parties fail to agree.
- * For which cases is mediation appropriate?
- * At what stage should mediation be initiated?
- * Who should be the mediator?
- * What instructions should the mediator follow and what authority should the mediator be given?
- * What should happen if mediation is unsuccessful?

Michael K. Lewis, Esq., Senior Associate at the National Institute for Dispute Resolution, prepared the discussion paper. Paul L. Tractenberg, Esq., Professor of Law, Rutgers University Law School, served as moderator and prepared the summary analysis article and bench manual. Panel participants included: Honorable Martin L. PANEL III—MEDIATOR QUALIFICATIONS. This panel developed guidelines for selecting and training mediators working in public interest disputes. The panel considered the following issues:

- What qualifications do mediators possess who work in the labor, family, environmental, consumer, commercial, and neighborhood dispute fields?
- * Should mediators be certified, if so, by whom?
- * What degree of expertise should the mediator have in the subject matter of the dispute?
- * What education, experience, training, and personal qualifications should mediators possess?
- * How do programs which provide mediation services assure quality service delivery?

The Center's second goal was to share the work of the Symposium with the ADR community. The Center hopes that programs which provide ADR services and which deal with these issues will find this publication useful. The cooperation of the Seton Hall Legislative Bureau in devoting this issue of the Seton Hall Legislative Journal to the Symposium proceedings is an important step toward this goal.

The Center gratefully acknowledges the thoughtful contributions of the above participants. In particular, the Center acknowledges the six authors whose significant efforts contributed to the success of the Symposium.

Finally, the Center invites further comment and discussion on these issues. The ADR field is dynamic and growing. There are no settled answers to these issues—they will be shaped by experience as the field further develops.
